September 1, 2016, Amberleigh Smith was returning home from work. Sitting still, waiting for oncoming traffic to clear so she could turn, she was rear-ended. The driver of that car was reaching for his cell phone, and by his own admission, didn't even attempt to stop. To make matters worse, he was uninsured and driving on a suspended license. When he hit Amberleigh, he was doing 50 mph.

Amberleigh momentarily lost consciousness, and her memory immediately following the impact is hazy. "When I came, to, I was extremely dizzy, the world was spinning, and I really had trouble comprehending what had happened," she said. "At that point, I really didn't know how badly I was hurt. But I knew I couldn't get out of the car by myself.'

### The Immediate Aftermath

Amberleigh's car was totaled. She had deep bruises across her chest from the seatbelt she had been wearing, and was very sore all through her body. The day following the accident, she was in a great deal of pain and her mind was still very fuzzy. Her family doctor diagnosed whiplash and a concussion. However, she felt obligated to return to work the following week, although still in a lot of pain, still muddled, and with trouble focusing. But her condition worsened.

"I felt a sharp pain in my right ear. The pain moved from my ear, down my jaw and throat, and into my right shoulder. Almost immediately, the right side of my face went numb."

Two days later, she went to the ER for an assessment. She was told she had no life-threatening issues, but needed to be under her family doctor's care. On his recommendation, she started physical therapy.



## **Legal Issues**

While all the physical problems were going on, there was an issue with Amberleigh's now-totaled Volkswagen. The Golf was a clean-diesel edition, and it just so happened there was a classaction lawsuit at that time which included Amberleigh's vehicle.

"It was extremely frustrating," observed Amberleigh. "We were fighting a battle on two fronts. I was in pain almost constantly, going to PT three times a week. In addition, we were dealing not only with the class action attorneys, but with our insurance company, as well. This whole period of time was just a nightmare. We knew we couldn't handle both these issues on our own. That's when we learned about Kitrick, Lewis & Harris."

### The New Normal

Amberleigh sustained permanent injuries from the accident. She has to remain vigilant to mitigate the jaw and neck pain and residual numbness she continues to experience. At the same time, she and her husband welcomed a son in March 2018.
